

**Meeting was called to order by Moderator, Juan Pablo Flores Esq., at about 5:01 pm**

2. Roll Call.

**Board Members present were Mike Nava, Mitch Lindemann, Danny Ortega Jr., Sergio Mendez and Alan Manquero. Absent members was Cindy Gage. David Esparza was dropped as unable to meet qualifications..**

An amendment to remove the yearly adjustment for federal inflation was made by Mitch Lindemann and seconded by Danny Ortega Jr., and the amendment failed 4-1 with only Mr. Lindemann in favor. The original motion passed 4-1 with only Mitch Lindemann being opposed.**


